

Trail Information

To optimize your experience and safety, please ensure that you carefully review the following information for rules and information on detours and closures.

General rules

All trail use is non-motorized, day-use only.

Camping, fires and hunting are prohibited.

Rules of conduct

Beverly to the Idaho Border corridor is open for non-motorized use, by registration only. Motorized vehicles, including snowmobiles, are always prohibited on the corridor, except for authorized administrative or health and safety purposes.

Portions of the corridor may be closed to reduce fire danger, protect public safety or perform maintenance.

Registration

Users must pre-register to use the section of trail from Beverly to the Idaho Border. Registration can be completed up to a year in duration. Upon submission of an application, gate codes and other information will be provided via email.

Groups larger than 20 people, or seeking to conduct activity outside of normal recreation, must obtain an approved Special Activity Permit. [Visit our Special Activity Permit webpage for additional information.](#)

Requirements for use

Sanitation

Trail users will not leave or scatter trash or refuse. Do not leave human waste within ¼ mile of buildings, water sources, lakes, ponds or streams (running or dry). Waste must be buried.

Public behavior

Trail users will not:

- Destroy, alter or damage buildings, signs, equipment, markers, other structures or property.
- Erect unauthorized shelters, enter structures without permission or camp on the trail.
- Destroy, deface or remove any natural feature, vegetation or surface.
- Hunt or discharge firearms from the trail.
- Possess or ignite fireworks.
- Build a fire.
- Allow animals to be unleashed or out of control. Leashes cannot be longer than eight feet long.

Penalties

Any violations of state law or the terms or conditions of the registration, Washington State Parks will revoke the registration and the registerer will be subject to penalties.
